

40-YEAR LIMITED WARRANTY Pre-painted Perspectra Plus series coated steel.

WARRANTY COVERAGE

1. A) This limited warranty covers Canada under normal atmospheric conditions for a period of forty (40) years from the date of delivery the paint film of pre-painted Perspectra Plus series will not noticeably crack, blister or peel from normal outdoor use

B) For a period of thirty (30) years, the degree of chalking will not exceed #8 in vertical applications or 4 6 in non-vertical applications measured in accordance with the ASTM D4214 standard, Method A.

OTHER CONDITIONS, EXCLUSIONS AND LIMITATIONS

- 1. The foregoing warranties do not apply to damage caused to the Warranted Product by: Abnormal atmospheric conditions, which include, hail, exposure to corrosive or harmful chemicals (liquid, solid or gas), airborne contaminants, contact with or exposure to animals or animal excrement, exposure to salt or spray, decomposing materials, moist absorbent materials and internal contamination due to poor ventilation or use. The warranty does not cover damage caused by natural disasters, falling objects, external forces, explosions, fire, civil commotion, acts of war, excessive radiation or other similar events beyond our control.
- 2. This warranty applies only to the initial buyer and is neither transferable nor shareable.
- 3. This warranty does not cover damages cause to paint during handling, shipping, transportation, preparation, warehousing or installation.
- 4. Defect, damage or failures caused by corrosion along exposed and/or cut edges or cased by a lack of parent steel are specifically excluded.
- 5. Damages caused to the product directly or indirectly from contact with fasteners or cause by chips of steel or tiny particles of sparks from sawing, that come in contact with product finish are not covered by this warranty.
- 6. Use of an impact gun for fastening steel is not recommended.

Buyers must inspect materials from Tôle Vigneault Inc. prior to installation in order to reduce the costs, if necessary, of repairing, replacing or repainting damaged sheets. The buyer accepts this responsibility upon delivery under paragraph 3 of the Limitations section.

All buyer claims related to product defects or other causes will only be considered by a written notice submitted to the vendor within thirty (30) days of defects discovered, and within the warranty period. The buyer must show proof of purchase with the claim. The vendor must accord the necessary time to review and process the claim.

No warranties are offered outside of Quebec, Ontario or New Brunswick and no international or interprovincial sales agreement is applicable. Products are regulated under the foregoing warranty in accordance with the laws of the province of Quebec.

THE FOREGOING WARRANTIES ARE THE SOLE WARRANTIES OF THE COMPANY IN CONNECTION WITH THE WARRANTED PRODUCTS; ALL OTHER WARRANTIES AND CONDITIONS EXPRESSED, IMPLIED OR STATUATORY, ARE HEREBY EXCLUDED.
